#### Announcing Changes to Organizational Structure and Change of Director and Executive Officer

MACROMILL, INC. (hereinafter referred to as "the Company") hereby announces that its Board of Directors has resolved at a meeting held on December 27, 2010, to make changes to the organizational structure of the Company as well as to the responsibilities of a director and an executive officer. Details are as follows.

## 1. Changes to organizational structure

### (1) Purpose

For the purpose of advancing the management integration associated with the acquisition of the marketing research business of Yahoo Japan Value Insight Corporation by demerger (absorption-type) on August 1, 2010, the Company will restructure the organization under the Marketing Solution Business Group and reorganize the Business Development Business Group to strengthen the new business development function.

The Company will set up the "Product Planning Development Division," which will be responsible for strengthening and integrating products related to the research business under the existing Marketing Solution Business Group, and will create the Conventional Research Division to bolster qualitative and Central Location Test (CLT) research. The Business Development Business Group will also be reorganized into two groups, namely the New Business Development Business Group and the Overseas Business Development Business Group.
